INITIAL TRAINING

## **OBJECTIVES**

The goal of the Master Economics of Sustainable Development is to train economists with a double competence on development policy forumulation, implementation and eveluation and on understanding the challenges of sustainable development Its purpose is to meet the growing demand for experts able to meet the challenges of economic development processes, to evaluate the economic policies of developing countries and to take account of the challenges of sustainable development in these policies. The Master program provides rigorous training in quantitative methods of economic analysis, and on development economics, environmental economics and the sustainable development finance.

The program combines the advantages of a thorough training in economics and an opening to other social science disciplines

### **REQUIRED BACKGROUND**

This Master 2 is the second year of the Master Program in Development Economics / Sustainable Development. Most admissions are made at the Master 1 level (M1 Economie du Développement) but direct admission at the Master 2 level is still possible. Both French and international candidates who have completed a Master 1 in economics or equivalent are considered for admission. Applicants must demonstrate competence in economics and quantitative analysis, while showing an interest for the economic, social and environmental challenges of development.

#### THE SELECTION PROCESS

European candidates ou students with a French diploma should apply through **E-CANDIDAT from April 4th to April 19th**. Candidates from countries with Campus France procedure have to apply through Campus France from March 1st to March 18th. Other foreign candidates should apply through **E-CANDIDAT from April 4th to April 19th**. Applicants should include a motivation letter and a research proposal of two pages for the Master Thesis.

#### **MAIN PARTNERS**
